**Hello Homeowner.** The Election of Directors to the Lake Country Village Board of Directors for the July 1, 2023 thru June 30, 2025 term will officially take place at the Annual Meeting of Members on Monday May 8, 2023. It is very important that you exercise your rights as a member of the HOA and vote. **Only Homeowners** may vote in this election. (one vote per HOA Address. If a homeowner owns two or more units you still are allowed only one vote per the LCV Declaration in the LCV prospectus).

This year the Board has decided to again use a third party online voting company, <u>EZVOTEONLINE.COM</u>. You are receiving this paper ballot because we do <u>not</u> have an email address on file for you. If you use email, we ask that you please visit our website at <u>www.lcvillage.org/email-request-form/</u> and provide an email address which can be used for future elections and other communications.

To vote, mark your selection(s) where indicated on the enclosed ballot. You may vote for a total of 3 candidates. (*If more than 3 candidates are marked, your ballot will be discarded*.)

Then <u>CALL IN YOUR BALLOT</u> using the EZVOTEONLINE <u>HOT LINE number</u> provided on the ballot form.

• When voting by phone, you will need to provide the <u>unique voter ID listed on the ballot form</u>. Simply call the hotline any time before the deadline and follow the verbal prompts.

Although <u>we encourage everyone to VOTE PRIOR TO THE MEETING</u>, you may attend the meeting and cast your vote at any time, <u>prior to the Secretary closing the ballot</u>, by **calling the hotline from your cell phone just as though you were voting from home**. Paper ballots cannot be accepted.

All ballots, whether voting online or phoned in, <u>must be received by 7:00 PM, May 8, 2023.</u> Election results will be announced on our website, in the annual notice to all homeowners which will be mailed on or about June 1 and at the regular meeting of the Board on June 12.

#### **Previous experience:**


