Impact Demand Water Charge!

ATTENTION HOMEOWNERS

Please add your name to this letter to Mayor Read to show your support in exempting the homeowners of LCV from this unfair water fee.

Mayor Read,

Effective July 1, 2020 the city of Plattsburgh imposed a new city-wide fee which affects water bills in Lake Country Village for triplexes or quadraplexes. This fee, called an Impact Demand Charge is a flat \$33.33 per month, per 1" meter. As a flat charge, it is not a "demand" charge at all, since it bears no relationship to actual water consumption or the demand for water. What it is, however, is a significant increase in our cost of receiving water. It represents an overall increase of 40% on our total annual water charges. Since we have many elderly and single residents, a number of our buildings regularly only pay the City's minimum charge for water. For these, the IDC is even more egregious, increasing these water bills by more than 115%!

The City provides an exemption from this charge for residential services for single family and duplex homes with a service size of 1" or smaller. Each home in Lake Country Village, regardless of it being a part of a duplex, triplex or quad unit, are all <u>individually owned</u>. Due to the unfairness of this charge for any residential services, we the undersigned demand that 1) the city classify water service to all our residential buildings in Lake Country Village as "residential" and 2) the city amend its local law to extend the IDC exemption to all residential services of 1" or less (meter size) regardless of the number of units.

This year casting your vote is more important than ever. On November 3, 2020 we at LCV will be voting for a mayor, county legislator, state senator and assemblyman and US District 21 representative as well as President and Vice President. There are major changes this year, due to COVID- 19, concerning voting procedures. Everyone has three options.

On Election Day November 3, 2020, our polling place will be PSUC Field House, 167 Rugar Street, Plattsburgh, NY. Hours are from 6AM-9PM. Face masks required.

Early voting will be from October 24, 2020 and concluding November 1, 2020 at Clinton County Government Center, 137 Margaret Street (First Floor Meeting Room), Plattsburgh, NY. Hours available: Saturday & Sunday from 9AM-2PM, Monday, Wednesday & Friday 9AM-5PM, and Tuesday & Thursday 9AM-8PM. Every registered voter is eligible to vote early and a mask is required.

Third is voting by mail. This election, Governor Cuomo has made this option available to everyone. You may apply for an application by mail, fax, email, online or calling your local board of elections. Election Board number is (518) 565-4740. Applications can be requested at

www.clintoncountygov.com/boe, cut-off date is October 27, 2020. When filling out the application, check the temporary illness box as the reason for this request. Next, an absentee ballot will be sent to you which must be filled out, signed, and returned with the postmark no later than November 3. 2020 It is being suggested you mail your ballot back with a first-class stamp, so it gets processed as such and return it as soon as possible.

Whichever way you vote it is being suggested you vote as early as possible.

Political Signs

Recently, we have seen a proliferation of political signs in front of Lake Country Village residences. For the most part, they have been placed on the grass strip between the road and the sidewalk. Some village homeowners have asked us (the Board) why we haven't had these signs removed.

After researching the issue, the Board has found that if you live on Iowa, Kentucky, Maine, Maryland or Massachusetts, the City of Plattsburgh owns 33 feet from the center of the road towards your house and if you live on Kansas they own 50 feet from the center. Measuring from the center of Maine in front of my house, 33 feet goes past the grass strip between the road and the sidewalk and past the sidewalk by another 3 feet.

It is the Board's belief that we cannot tell homeowners what they can and cannot place on city property. We have reached out to our alderman and asked if the city has any regulations regarding these signs. My guess is they don't have or enforce any regulations when you see the signs all over the city. And our alderman has yet to respond to our questions.

Beyond the 33 feet (or 50 feet) from the center of the road is the Common Area owned by the HOA and political signs are not allowed. The cul-desacs (Baltimore, Alana and Caitlin) and the long driveways with homes on either side are owned by the HOA and political signs are not allowed.

So, here is my pitch to homeowners who have placed political signs on city property in front of their residence. PLEASE remove the signs. While you may have the right to place a sign there, you should also notice that the vast majority of homeowners do not have signs - and they don't want them in the village. Please go vote for the candidate of your choice to show your support. But let's respect the wishes of most of our homeowners and keep political signs out of our village.

Treasurer's Tidbits

Hi everyone! Good health and safety to one and

all! Here is the latest and greatest from your numbers guy.

We have completed our first quarter of the new fiscal year and are in pretty good shape. First, a quick primer on how we handle our budget. We take our approved expenditures for each category and estimate how these dollars will be spent throughout the year. Some categories, like the water and sewer bills, we just divide by 12 since water use is fairly consistent month to month. Others we estimate differently based on say, the construction season or weather. This allows us to have a better handle on how we are doing each month rather than just comparing expenses to an annual number. Based on this method then, we are slightly over budget year to date, about \$22,000. At this time, this is not a significant amount since much can change yet as we go forward.

Our reserve is just over \$800,000. Since my last article, we have had 6 of our \$25,000 CD's mature. We took these moneys, along with about the same amount from our money market fund, and purchased 6 new \$50,000 CD's to continue our effort at maximizing our interest earnings. Once again, if you would like to know what these funds are earmarked for, check out the Capital Expense section of the annual budget or any monthly Treasurer's Report.

As I mentioned in my last letter, the City of Plattsburgh has begun assessing a new charge on our water bills. The impact is, as was predicted, a substantial increase in our water charges. About \$7,000 of the budget overrun to date is due to this charge. We are asking all homeowners join in our effort to protest this unfair charge. Please read the article in this newsletter which outlines what you can do to help.

Recipe Corner

As autumn arrives at Lake Country Village and we plan for winter's nutrition, I am delighted to share one of my favorite recipes, Moroccan-Spiced Chickpea and Sweet Potato Stew. The highlight of this tasty meal is the classic spice blend of Ginger, Coriander, Cumin, Tumeric, Cinnamon and Nutmeg. This vegetarian dish is nicely paired with chicken or pork and frequently served over brown rice.



Ingredients:

- 1 tablespoon olive oil
- 1 medium onion
- 2 medium carrots
- 1 celery stalk
- 1 teaspoon fresh Ginger
- 1 teaspoon ground Coriander
- 1 teaspoon ground Cumin
- 1/2 teaspoon Tumeric
- 1/4 teaspoon ground Cinnamon
- 1/4 teaspoon ground Nutmeg
- 1/2 teaspoon sugar
- 2 medium sweet potatoes
- 8 ounces green beans
- 15 ounces chick peas
- 15 ounces tomatoes
- 2 1/2 cups vegetable broth
- salt and pepper to taste
- 2 tablespoons fresh parsley

Directions:

- 1. Saute onion, garlic, carrots, celery and ginger in oil until tender.
- 2. Stir in spices and sugar.
- 3. Add sweet potatoes, green beans, chickpeas, tomatoes, broth, salt and pepper then bring to boil.
- 4. Reduce heat, cover and simmer for 35-40 minutes then sprinkle with fresh parsley just before serving.
